WHEREAS, recognition u/s 14 (3)(a) of NCTE Act, 1993 was granted to the institution namely, Shirdi Sai College of Education, Survey No. 1165/B, Markapur Village and Post Office, Markapur Taluk & City, Prakasam District – 523316, Andhra Pradesh vide order no. Accordingly, as per decision of SRC Show Cause Notice was issued to the institution on 15.11.2022. The institution has submitted its reply on 12.12.2022.
- 3. AND WHEREAS, the SRC in its 418th Meeting held on 16th December, 2022 considered the matter and decided as follows: -

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Shirdl Sai College of Education, Survey No. 1165/B, Markapur Village and Post Office, Markapur Taluk & City, Prakasam District – 523316, Andhra Pradesh for B.Ed. programme, 1 basic unit of 50 students."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e., Shirdi Sai College of Education, Survey No. 1165/B, Markapur Village and Post Office, Markapur Taluk & City, Prakasam District 523316, Andhra Pradesh for Continuation of recognition for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students subject to fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

 The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.

III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
